19. County Councillor's Update.

County Council business was starting to resume with meetings being held via video for the time being. The County Councillor expressed his thanks to all the volunteers who had come forward over the past few weeks.

- (i) Business grants. Cllr Phillips asked that details of any businesses who had not applied for a business grant be forwarded to him as soon as possible.
- (ii) Tourists can return from 6th July, with accommodation opening from 13th July. The Community Council's view was that a gradual opening up to visitors would be a preferred approach.
- (iii) Road surfaces throughout the village would be surface dressed, members highlighted current problems with the road surface throughout the village that were in need to immediate attention.
- (iv) Footpaths currently closed will reopen after the coronavirus situation has ended.

19. Clerk's Report.

1. Carmarthenshire County Council

(i) Vacancies and elections. The Regulations postpone any byelections due in the period from 16th March 2020 to 31st January 2021 and require them instead to be held on a date between the period commencing on 1st February 2021 and ending on 16th April 2021. Hence if you have a vacancy that occurs, you will still be required to notify the Returning Officer who in turn will publish the Notice of Vacancy. If a request by 10 electors of the Community or Community Ward request an election, the election will be put on hold and held between 1st February and 16th April 2021.

(ii) Carmarthenshire Covid-19 Community Response Fund is now available to support voluntary sector organisations and community groups in Carmarthenshire to: • Maintain or increase activities that support the vulnerable during the Coronavirus (COVID-19) crisis • Ensure that organisation/community groups have the resources needed to deliver vital services for their communities • Encourage robust health and safety protocols during all activities that safeguard voluntary sector staff, volunteers, helpers and beneficiaries.

County Cllr D Phillips noted he had applied for a loan for the Bryn Hall.

2. National Lottery Heritage Fund

On Friday 5th June National Lottery Heritage Fund and Welsh Government launched a one year capital grant scheme to encourage and support community based activity to create 'nature on your doorstep'. It is part of a package of measures to encourages 'Local Places for Nature'. The Local Places for Nature Capital Grant for Wales, will run until March 2021 and will distribute funds to smallscale community organisations for activities that restore and enhance nature in their local area, see Doc a for more details. Capital grants will range from between £10,000 and £50,000, and the total funding available is £1 million in 2020-21. Capital grants may be used to acquire, restore and enhance nature, in our town and cities, in the marine environment, where people live work or spend their leisure time. Capital grants must create a natural asset: a flower rich meadows or verges, a community orchard, or removal of non-native species or other threats to nature to allow native species to recover. Please note that capital grants may not be used for core staff costs, or the maintenance, replacement or upkeep activities in existing spaces. All projects must have a funded plan to maintain the asset long term. For more information on capital grants please refer to the NLHF guidance on their website.
