


<p><b>1. Expenditure under S137 Local Government Act 1972</b></p> <p>Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2024-25 was £10.81 per elector.</p> <p>In 2024-25, the Council made payments totalling £ <u>400</u> under section 137. These payments are included within 'Other payments' in the Accounting Statement.</p>	
<p><b>2.</b></p> <p>Additional notes that may assist:</p> <ul style="list-style-type: none"> <li>• There is a payment of £30 on 18 March 2025 marked as "Easter Egg Comp". It was intended that there be a competition over the Easter Weekend of 2025 but it did not take place due to the anticipated funding not being generated from usual sources. The community council was consequently reimbursed the donation which arrived back in the bank account on 14 April 2025.</li> <li>• The community council has provided sums on account of costs to JCP solicitors. These were in two sums: one on account of the community council's own costs and disbursements being £500 and one in respect of an undertaking to be given for the seller's costs in the sum of £800 plus VAT ie £1000. No invoices have been submitted in respect of those sums so far, but they have been treated them as "payments" as they have left the council's bank account and the work is ongoing so will be invoiced in due course.</li> </ul>


